

## SOCIAL MEDIA CONTEST RULES AND DISCLAIMER

**1. ENTRY:** No purchase necessary to enter or win.

**2. ELIGIBILITY:** Each contest is open only to legal residents of Louisiana and Mississippi, its territories and possessions, who have a valid Social Security number or tax ID number, over the age of 18, unless otherwise stated in giveaway. OnPath Federal Credit Union employees, officers, directors, volunteers, and their immediate family members are not eligible to enter or win unless otherwise noted. (Family members include spouse, parents, children, siblings, and their respective spouses.) Participants and winners must reside within the OnPath Federal Credit Union service area, unless otherwise stated.

**3. WINNER SELECTION:** Employees of OnPath Federal Credit Union or a party designated by OnPath Federal Credit Union will randomly choose the winners. All decisions are final.

**4. PRIZES:** Winners will receive merchandise specified in the entry drawing in which they inquired, entered and/or commented. The prize is non-transferrable and may not be exchanged for cash.
