

WWL-TV / OnPath Mandeville Grand Opening Sweepstakes

OFFICIAL RULES

- NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING. SUBJECT TO APPLICABLE FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS. VOID WHERE PROHIBITED.**
- Eligibility.** Subject to the additional restrictions below, the “WWL-TV / OnPath Mandeville Grand Opening Sweepstakes” (the “Sweepstakes”) is open to legal U.S. residents of the WWL-TV viewing area (as defined by its Nielsen DMA) that includes Pearl River and Hancock counties in Mississippi and the following parishes in Louisiana – Washington, Tangipahoa, St. Tammany, St. John the Baptist, St. James, St. Charles, Orleans, St. Bernard, Jefferson, Lafourche, Terrebonne, and Plaquemines who are 18 years or older at the time of entry. Employees and contractors of WWL-TV (“Sponsor”), TEGNA Inc., OnPath Federal Credit Union (“Promotional Sponsor”), Second Street (“Contest Administrator”) and each of their respective affiliated companies, and advertising and promotional agencies, and the immediate family members of, and any persons domiciled with, any such employees or contractors, are not eligible to enter or to win.
- How to Enter.** The Sweepstakes will begin at 6 a.m. (CT) on Wednesday, April 6th, 2022 and end at 11:59 p.m. (CT) on Sunday, May 8th, 2022 (the “Sweepstakes Period”). Enter by visiting WWLTV.com/contests completing all of the required information (name, address, and email address), and following all posted instructions. Complete the entry form and any other required fields and then submit your entry by clicking on the “SEND” button. Entries limited to only one (1) entry per person, per day. Your computer must accept cookies, or any successor or similar technology, which may be used for the purpose of entry tracking. Ad blocking software on your computer needs to be disabled so that it doesn’t interfere with processing your entry. Multiple entrants are not permitted to share the same email address or Facebook ID. By entering, you agree to the terms of these Official Rules and to receive e-mails and phone calls from Sponsor or those directed by Sponsor. You can opt-out of the receipt of such e-mails and phone calls by following the directions in any correspondence received from Sponsor. - Winner Selection.** On or about Monday May 9th Four (4) pre-event finalists will be selected by Sponsor in a random drawing from among the eligible online entries. On May 21, 2022, the day of the Grand Opening Event, one (1) additional finalist will be selected randomly by OnPath from the attendees at the Grand Opening event, for a total of 5 grand prize finalists. At the event, one (1) Grand Prize Winner will be selected by Promotional Sponsor in a random drawing from among the eligible finalists.
- Prizes and Odds.** One (1) Grand Prize winner will receive a new car selected by Promotional Sponsor, with a maximum value of \$31,000 MSRP. The four (4) other Finalists will each receive a gas card for \$50.

Once the winner has been contacted and has accepted the prize, their contact information will be provided to OnPath Federal Credit Union who will complete the prize fulfillment process with the winner.
